INTERNATIONAL COMPETITIVE BIDDING(ICB)

The Rural and Renewable Energy Agency (RREA) has received Funding from the Government of Liberia towards the cost of **Solar Installation Project** and intends to apply part of the proceeds for payments under the contract No: **IFB Number: RREA /SP/ICB/-001/2023** for the **Supply and Installation of Solar Panel within Marshall City, Republic Of Liberia.**
2. The **Rural and Renewable Energy Agency (RREA)** now invites sealed bids from eligible and qualified bidders for the **Supply and Installation of Solar Panel within Marshall City** Project described as in the Schedule of Requirement of the Bid Document.
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Government of Liberia's Public Procurement and Concessions Commission Act and Regulations (PPCA) and approved by the PPCC, and are open to all eligible bidders as defined in the PPCC Guidelines.

Interested eligible bidders may obtain further information from the Rural and Renewable Energy Agency and inspect the Bidding Documents at the address given below from 0900 to 1700 hours, Monday to Friday, excluding public holidays. 5. Qualifications requirements include:

- a. Bidders must submit copy of current Business Registration Certificate
 - b. Bidders must provide current Tax Clearance Certificate
 - c. Bidders must have successfully completed at least two (2) similar contract done within the last three (3) years of similar nature.
 - d. Bidder must provide record of past performance
6. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non- refundable fee of **USD\$50.00**. The method of payment will be a direct payment at RREA's Finance Department.
7. Bids must be delivered to the address below at or before **10:00 am** Local time, on **May 16, 2023**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at **10:00 am** on **May 16, 2023**. All bids must be accompanied by a **Bid Securing Declaration to be completed using the form provided in the bid documents**.
